Examples also exist of a combination of both these means (Spain, Mexico, Argentina). In any case, a modern democratic state cannot provide efficient public administration of economic and social processes unless it guarantees the existence of local self-government.Â Local Government Competence (Authority) The Federal Law on the General Principles of Local Self- Government Organization in the Russian Federation (1995) treats the term –local self-government– in a broad manner.
