Prior to Lombroso's Biological theory of crime, Cesare Beccaria and Jermey Bentham had introduced the Classical School of Crime. The Classical School of Crime was a theory based on the notion that, an individual who possesses "free will" chooses a life of crime. Deterrence theory applies utilitarian philosophy to crime. "Rational choice" is based on economic theory derived from the same utilitarian tradition. It encompasses a full range of behavioral inhibitors and facilitators: rewards/costs; past, present, and anticipated reinforcers and punishers; formal and informal sanctions; legal and extra-legal penalties; direct and indirect punishment; and positive and negative reinforcement, whether or not rationally calculated. Nonetheless, the literature on rational choice in crime has overlooked it.16 Even though some earlier deterrence researchers had taken note of learning concepts, deterrence researchers today tend to skip over it when integrating deterrence and rational choice theories.
